Jerry Goldsmith met with the Board regarding a pipeline resolution. Doug Schroder, Lisa Diercks and Scott Tholen were in attendance. The Board reviewed Bremer and Greene County Resolutions objecting to the Iowa Utilities Board's authority to enact eminent domain authority within the county for privately owned and operated carbon dioxide pipelines. Sup. Barnhart asked who did the implementations of mandated policies in the handbook. Assessor Dauber and Engineer Fangmann were in attendance as they attended the Heartland meeting. Dauber said the Auditor is not responsible for updating the handbook and that should be done by Department Heads and Elected Officials. Barnhart wants to make sure handbook changes are happening with Federal and State laws. Consensus of the Board was to talk to HR Attorney Galloway regarding this topic.

Our current policy reads "Any maintenance work to be performed in the Cedar County Courthouse (i.e., sweeping, mopping, cleaning dust of desks, or hanging pictures on walls) shall be performed by maintenance staff only." Tischuk said employees are not signing the policy due to this wording. Discussion was held to remove some language.
